"Venturing Beyond: A Lohit Valley Entrepreneur's Odyssey"

This is not a success story but a story of a beginning, an initiation, and someone threading a path different from the one eulogised by our society. Often, I, along with my friends, visit the Community Convention Centre, Tezu (CCC), which, apart from being one of the most innovative structures madeby the district administration, also houses a café- 'The LaRose Patisserie'. The café is run by a young local entrepreneur, Miss Pamela Krong. One can see a galaxy of coffee, tea, and other products in the menu seldom expected in such a remote place. The products are not only unique in appearance, but also, savoury and luscious.

Pamela, a young lady from Lohit, born and brought up in Tezu, originally her parent are from Tehuliang village in Anjaw. She has a degree in sociology and a 'Diploma in Pastry and Culinary Art'. Like every parent in our society, her parents, especially her father, wanted her to be an officer or do government service. But Pamela has dreams different from those that most young minds have: "I realized, that I don't have a knack to study for hours; I was always inclined towards entrepreneurial activities, performing arts, etc. Therefore, "I decided to walk on the path that I love and made my choice accordingly," she added.

She shared that before starting the cafe in the CCC,



she used to run a cloud kitchen. "When initially I started, many would say'market is down' then some would tell our tribal people do not eat much of these things," she shared with a smirk. "And yet I continued, and now I can proudly say that I am financially independent," she smiled.

Sharing about the biggest challenge in her endeavour, she said "First, it's difficult to start something new, i.e., business cake making, etc., which is not part of our culture. The people would be sceptical and sarcastically ask, After studying so much, would you be doing catering?" she shared. "Then it's difficult to find the right people for the job; our tribals are shy people and therefore need some time to get acclimatized to the kinds of hospitality that entrepreneurship demands," she added. However, she said, "There is no dearth of talent and hardworking youth in our society if we look for it properly".

"At first, when I was told to run the café at CCC, I was numb and had no idea how to start for at least two days, but I gathered some courage and agreed to start, she recalled. "Initiation is important; we have to begin somewhere. Once I started, everything fell into place. I am very thankful to the district administration for considering me for the cafe in the CCC," she said with a sigh of relief.

"Today, I have around nine young girls working with me—learning and earning. I prefer giving opportunities to

the local youth—vocal for local, you see" she said with a sense of contentment. Then, on asking about the annual return or profit from her business, she replied, "Till now, I have not made an exact accounting; the money is coming as well as going out to pay the salary of the staff and the cost of the inputs for the product. However, "I save enough that I do not have to take financial help from my family," she reiterated confidently.

Then, she added, "For now, I am not thinking much about profit per se, but I am focusing on surviving the competition in any form and spreading the footprint of my efforts. She emphatically quoted one of the lines that her uncle has told her: "Quality is something that should never be compromised; if quality is good, customers will surely come.".

On being asked about her opinion on the role of government agencies in empowering entrepreneurs, Pamela shared that "the District Administration led by DC Shashvat Saurabh, IAS, could recognize and understand my potential and provided me with the opportunity that boosted my confidence to a great level." She shared that she has also been shortlisted for the DeenDayal Upadhyaya Swavalamban Yojana (DDUSY), under which she will get 50.00 lakhs if everything goes well.

"I am planning to expand my business not just in Lohit but in the entire Arunachal and nearby states," she said, hopeful. Then she also shared her ignorance about schemes and programs of the government to help entrepreneurs and said that it is essential for any budding entrepreneur to do the necessary research, as the government has many schemes for them.

Pamela may not be the epitome of success in a conventional sense as of now, but the journey that she embarked upon will be trailblazing and will leave a positive footprint for sure. Her story is worth sharing with all the youth who may be uncertain about their choices given the societal pressure. Clearing a competitive exam and securing a government job is no doubt a good option, but that is not the only option. Everyone is not made for studies or government jobs; as it is said, "everyone is unique".

Lastly, asPamela puts, "It's ok to dream differently; one should thread the path where one's heart is instead of getting pushed by society; ultimately, in the long run, you will be alone to push yourself."

New Criminal Law launched

ITANAGAR, July 1:

New criminal law was launched at various districts in the State on July 1 bringing widespread changes in India's criminal justice system and ending colonial-era laws.

At Bomdila, Mama Natung, Minister of Home, Inter-State Border Affairs, PHE & WS, and Department of Indigenous Affairs, inaugurated the awareness programme on new Criminal Laws at the SP's Conference Hall in Bomdila in the presence of Kento Jini, Minister of Law, Legislative & Justice, SJETA, Tribal Affairs, and Sports and Youth Affairs, along with MLAs Likha Soni, Nikh Kamin, Nyabi Dirchi, Ealing Tallang, and CMD Toko Anuj.

Home Minister, Mama Natung briefed the attendees on the key aspects of the new criminal laws. He thanked the government and law makers who worked day and night to bring out scientific laws in consonance with current reality of the society and hoped that focus on scientific and evidence based investigation will result in effective prosecution in time to come. He urged the enforcement agencies to implement the laws in letter and spirit for the benefit of the public.

Earlier, while welcoming the dignitaries, SP West Kameng, Sudhanshu Dhama, highlighted the salient features of the three new laws and informed the distinguished gathering about the extensive training provided to all levels of law enforcement agencies to ensure the efficient implementation of the the new acts.

At Pasighat, the District Police organized special program here at Reserve Police line (RPL), Pasighat to sensitize on the key features of the reformative new laws for citizens, police personnel and all stakeholders.

DC and SP along with PMC Chief Councillor Okiam Moyong Borang, her deputy Rebecca Panyang Megu and other councillors released handbook on the New Criminal Laws, 2023 published by the East Siang district Police for wide awareness among the general public.

DC East Siang, Tayi Taggu in his address said that the spirit behind the three enacted criminal laws for fair, speedy and time bound justice for citizens must be the guiding force in its implementation for the district police and judiciary and stakeholders. He stressed on maximum public awareness, so that speedy and fair justice reaches the last man in the line.

SP East Siang, Dr. Sachin Kumar Singhal, while briefing on the salient features of the new laws Bharatiya Nyaya Sanhita, viz. Bharatiya Nagrik Suraksha Samhita, Bharatiya Sakshya Adhiniyan - said that the district police is committed for effective implementation. Citizen friendly and simplified provisions to register case from anywhere irrespective of jurisdiction and use of digital / electronic mode for online registration of case, Zero FIR, safeguards for women and child and the Transgender community, separate sections for crimes under Nyay Suraksha Samhita Act, virtual /electronic mode of FIR/

trial, time bound period for investigation by police and trial by Judiciary etc will address the pendency of cases faced by the people in the previous IPC, Cr.PC and facilitate speedy & efficient justice system to the people.

ASP Pankaj Lamba said that the district police are geared to implement the New laws in letter & spirit and highlighted the trainings imparted to acquaint police officers and personnel. Dy. SP Ayup Boko, Police officers from rank and file attended the meeting among participants.

At Ziro, a legal awareness campaign for effective implementation of new criminal laws of Bharatiya Nyaya Sanhita (BNS), Bharitiya Nagarik Suraksha Sanhita (BNSS) and Bharitya Sakshya Adhiniyam (BSA) was organized at Golden Jubilee Hall of District Secretariat.

The awareness campaign was organized by the District Legal Services Authority, Ziro in collaboration with Lower Subansiri District Administration and District Police.

Chief Judicial Magistrate and Lower Subansiri District Legal Services Authority general secretary Damge Neri briefed the police officials, advocates of Lower Subansiri Bar Association and the gaon buras and buris on the BNS, BNSS and BSA in detail.

The CJM and Lower Subansiri District Magistrate Vivek H.P also handed over copies of the new criminal laws and digital equipments to gaon buras and buris for effective dissemination and implementation of the same at the District.

The legal awareness campaign was attended by police officers from the ranks of Sub-Inspector to Deputy Superintendant of Police, advocates, gaon buras and buris, members of Child Welfare Com-

mittee, officials from Department of Women and Child Development, Juvenile Justice Board members, court staffs and NGO members of the District.

At Namsai, the New Criminal Law was launched and awareness programe was conducted at Namsai District by Namsai District police.

Same programe was also observed at Mahadevpur and Chongkham Police Station. The programe was participated by DC Namsai, Secretary DLSA cum JMFC Namsai, SP Namsai,police officials, Bar association Namsai and representatives from women and child welfare department.

During the program DC Namsai, Secretary DLSA cum JMFC Namsai, SP Namsai deliberated on the New criminal Law, underlying new provisions, changes in criminal Law, speedy and victim centric Justice system enshrined in the new criminal law The programe highlighted especially in provisions relating to welfare of women and child in the New criminal Law.

At Tezu, Awareness Program on three new criminal laws: Bharatiya Sakshya Adhiniyam, Bharatiya Nyay Sanhita, Bharatiya Nagrik Suraksha Sanhita was held at the Conference Hall of the Senior Superintendent of Police Lohit. The program was attended by DC Shashvat Saurabh IAS and SSP Tumme Amo IPS Tumme Amo

Speaking at the occasion DC Shashvat Saurabh said that it is important to have the knowledge of the new laws for executive magistrates, Police personal in particular and for the public in general. He said that District Administration will be organising workshop in order to spread awareness and knowledge on the new laws.

SSP Tumme Amo IPS said that new law is citizen and justice

orientated with a focusing on protection of the citizens.He said that the new laws are comprehensive and covers all the stakeholders involved in the process of justice delivery. If there are certain provisions of the new laws have given more powers to the police; then, there are also provisions to protect the right of the people or any accuse, he added. He hoped that with the new laws in place thre will be speedy justice delivery.

Inspector D Singpho Presented a powerpoint point and explained the various provision of the news laws, he also explainedhow the new laws are different from the old ones.

The program was attended by EAC Sotailum Bellai, ZPM Balong Tindiya, Executive Magistrates, HoOs, Police officials, representatives of Student Unions, Women groups etc.

At Roing, new Criminal Law was conducted by the Roing Police.

During the programme, SP Akanksha Yadav highlighted special features of the NCL such as focus of NCL on citizen-centric laws, redefined offences and punishments, inclusion of technology in delivery of justice, victim-centric approach and greater accountability and transparency of Police. She also emphasized on the importance of the ongoing training programme for Police personnel.

The foundation work for the installation of Lord Parshuram's statue at the site has been completed and the installation of the statue is likely to start soon.

NEW DELHI, July 3:

Deputy Chief Minister Chowna Mein sought the union tourism ministry's support and guidance to develop the tourism industry in Arunachal Pradesh.

"Tourism is the only sector after hydropower that could help Arunachal becomes self-reliant," Mein said addressing the 'Swasti Kaamna Samaroh'-an event organized by VIPRA Foundation at Dr. Ambedkar International Center here on Tuesday, July 2.

He expressed hope that with the support of the tourism ministry, stakeholders like, VIPRA Foundation and International Society for Parshuram Consciousness, Parshuram Kund can be developed into the region's one of the largest pilgrimage sites.

He informed that the foundation work for installation of the 51-foot bronze statue of Lord Parshuram, donated by VIPRA Foundation, is expected to be completed within a month's time.

"I have instructed the department to commence the landscaping and beautification at the earliest, along with the construction of the approach road," Mein said.

The DCM further informed that the state government has approved the "Construction of River Front in Parshuram Kund in Lohit District" under NESIDS (OTRI) with a project cost of Rs. 50 crore during the state level empowered committee meeting on 26 June.

The proposal will be submitted to the DoNER ministry for early sanctioning. Additionally, the state government will provide an additional Rs. 50 crore for the development of the Kund.

The project envisages constructing a river front, spanning 200 meters on the left bank of the Lohit River along the mela ground.

The project includes lawns, walkways, a ramp for vertical movement, a viewing deck, an outdoor amphitheater, a viewing tower, and a ritual deck for ash immersion by devotees.

"The development project aims to create a recreational space for the devotees attending the 'holy dip' Mela at the Sacred Kund, on occasion of Makar Sankranti in January, which attracts more than 100,000 pilgrims," Mein said.

The project is expected to boost interstate tourism and uplift the socio-economic activities in the area, he added.

Union culture and tourism minister Gajendra Singh Shekhawat, MoS for agriculture and farmers welfare Bhagirath Chaudhary, founder of VIPRA Foundation Sushil Ojha, among others attended the programme.

Fisheries Department Distributes Fingerlings and Fish Feed to Boost Aquaculture

EMCHI, July 3:

The Papum Pare Fisheries department distributed fingerlings, fish feed and lime to 243 fish farmers of the district under the Atma Nirbhar Matsya Palan Yojana (ANMPY) for the years 2022-2023 and 2023-24 and Pradhan Mantri Matsya Sampada Yojana (PMMSY) for the year 2022-2023 here at Govt. Fish Farm, Emchi on July 3.

The Fisheries department distributed six lakhs fingerlings to the local fish farmers. These fingerlings, produced indigenously at the Emchi govt. fish farm are expected to significantly boost fish production and meet the growing demand for fish in the market. The species distributed include rohu, catla, mrigul, grass carp, labio bata and labio genius known for their good survival rate and high yield.

Alongside fingerlings, the department provided 600 tons of nutritionally balanced fish feed and lime. The feed is designed to ensure optimal growth and health of the fish, leading to higher productivity and profitability for farmers. The lime will be used to increase the availability of nutrients, to increase pH and buffer against daily pH fluctuations and to sterilize ponds prior to stocking.

Attending the event Papum Pare DC, Jiken Bomjen stated that, "This initiative is part of the government's continuous effort to support and empower our local fish farmers. By providing high-quality fingerlings and feed, we aim to boost fish production and enhance their livelihoods and promote the aquaculture sector."

"Unlike other animal rearing activities, fish farming is the safest option," he added while encouraging the unemployed youths to take up fish farming.

DC Bomjen further advised the Fisheries department to handhold and provides technical assistance to the fish farmers.

District Fisheries Development Officer Kipa Taja added, "We are committed to fostering a thriving aquaculture industry. This distribution program is a step towards achieving sustainable and profitable fish farming practices."

"To ensure the success of this initiative, the department is also offering training sessions for farmers. These sessions cover best practices in fish farming, efficient feed utilization, and sustainable aquaculture techniques .Technical support and regular follow-ups will be provided to assist farmers in managing their aquaculture operations effective-ly," the DFDO added.

DFDO Taja also informed that "high altitude cold water fish such as trout has been introduced successfully at Silsango and Leporiang on a pilot basis last year. This commercially viable fish will increase the income generation of the fish farmers exponentially".

Among others Fishery Officer Yorum Sajan Taigh, beneficiaries and fishery department staffs were present on the occasion.

Governor launches a book on 'Kargil War'

BANGALURU, July 3:

The Governor of Arunachal Pradesh Lt. General KT Parnaik, PVSM, UYSM, YSM (Retd.) launched a book, titled 'Kargil War: The Turning Point' at Cariappa Hall, Rajendra Singhji Army Officers Institute (RSAOI), Bengaluru on July 3. The book, authored by the former Commanding Officer of 2nd battalion of Rajputana Rifles (2 RAJ RIF) late Col M B Ravindranath, Vir Chakra (VrC), gives insight of the actions and operations of the battalion from May to July of 1999 during Operation Vijay. The battalion (2 RAJ RIF) was instrumental in capturing an imposing feature 'Tololing' in the Drass Sector on the 12th and 13th of June 1999. It was the first success of the Indian Army and proved to be the turning point during 'Operation Vijay'.

Speaking on the occasion, the Governor, who also commanded 2nd battalion of Rajputana Rifles in 1990-93, commended Late Col M B Ravindranath, VrC for the in-depth narration of the valour and élan of the Indian Army. The Governor, who was on a UN Mission in Angola, which was a highly volatile and conflict zone during the Kargil War said that the book is a firsthand report from the warzone and highlights the acumen and gallantry of officers and troops of the regiment. The book delves into many leadership nuances and psychological aspects of warfighting, he said.

The Governor said that the book, titled 'Kargil War: The Turning Point' is very inspiring and it must reach the people aiming to join the armed forces. He suggested that the book must be in every school and college library.

First Lady of the State Smt Anagha Parnaik, Lt Gen Mohinder Puri (Retd.), Ms Anitha Ravindranath, Col D Devasahayam (Retd.), CMD Radiant Group along with former Service Chiefs participated in the book launch.

The 12-chapter book provides comprehensive details starting from 'The Gathering Storm', when the intrusions came to light in early May 2099, the unit movement from Kigam to Drass, the preparations, acclimatization and training of troops, followed by the planning and the attacks on Tololing on 13 June and Three Pimples on 28 June 2099. "The stadium, complete with a track, will fuel the passion of sports enthusiasts and nurture talent in our region," he added.

While highlighting that the Tawang Marathon conducted last year has been an immensely successful endeavour, Khandu informed thatfrom this year the event will be organized jointly by the state government and the Indian Army based at Tawang.

"We have also decided that this event will be a calendar event and will be held every year on 24 October that marks the United Nation's Day. The state government will provide Rs 2 crore as grantin aid for conduct of the Tawang Marathon, which will be promoted as an international event," he revealed.

DDSE cum DPO, TT Tara briefed about the issues and problems faced by the education department.

The issues the DDSE brought toprimary focus was onrationalization of teachers through transfer and posting, issue of subject teachers, merger of defunct and low enrolment schools, teacher accommodation, revival of hostels and stipendiary schools, improvement of school infrastructures and strategies to improve teacher quality, student performance and continuous professional development to equip teachers with the necessary skills and knowledge.

Speaking on the occasion 13 Doimukh MLA Nabam Vivekremarked, "this meeting represents a pivotal step towards fostering a more cohesive and effective education system. By bringing together all key stakeholders, we can collectively address the myriad of challenges faced by the education department and work towards our common goal of providing quality education for all."

He also called out to the teachers for shedding off all political differences and concentrate on improving the quality of education.

Speaking about the necessity of teacher rationalization, Vivekfurther assured of zero political interference in case of teacher transfer and posting.

Vivek suggested for a follow-up meeting to be scheduled after six months to review the progress and continue discussions.

15 Sagalee MLA Er. RatuTechi while addressing the school administrators spoke about the proposal for merger of low enrollment schools. He said that "Merging low enrollment schools is often considered as a strategy to optimize resources, improve educational offerings, and ensure sustainability. However challenges like community resistance, logistics, the impact on students has also to be considered before the merger finalisation; for which ground work and a general consensus is required."

The technocrat turned politician also sought cooperation and collective effort from all the stakeholders to face the challenges in the education department.

DC Papum Pare, Jiken Bomjena dvised the teachers to be sincere and always be abreast about the latest developments in their respective subjects.

ZPC Smt. NabamYakum pointed out that the appointment of subject teachers as CRCCs and BRCCs deepens the subject teacher scarcity.

She suggested for BRCCs and CRCCs to teach in the nearby schools.

All Papum Pare District Students Union President Gollo Lento while assuring cooperation to the Education department also suggested for "no political or bureaucratic interference in the teacher transfer posting, discouraging development activities in low enrollment schools and allocating a fixed amount percentage of the MLAD for the education sector.

She highlighted the manpower strength, infrastructural assets, student's performance of the past two years and the state and centrally sponsored schemes implemented in the district. All the ZPMs of Papum Pare also presented the issues faced by the schools pertaining to shortage of subject teachers, lack of teacher's accommodation and hostel facilities etc.

To protect the government land from encroachment, he further directed all the Administrative Officers to ensure NOC is obtained for any plot near Government installations and structures.

Learning about rampant gambling in the weekly markets and melas, he added that "henceforth the owner of the market and melas shall be held liable and booked in case of violations".

The OCs of various Police stations of Papum Pare also spoke about the problems and issues faced by them; most of them concerning lack of manpower, vehicles, accommodation and CCTVs in the nakas and beat Offices.

SP PapumPare Shri Taru-Gusar, also highlighted the issues of the department in general and requested the legislator to facilitate establishment of a Women police station at Yupia, owing to the existence of many courts near the DC Office premises and consequent protests led by women and construction of a police station in Jote -Poma area. DC calls for proper implementation of projects

LIKABALI, July 12:

Lower Siang Deputy Commissioner Rujjum Rakshap has called for proper and on-time implementation of developmental projects in the district.

Chairing a District Level Monitoring Committee (DLMC) meeting on July 12 which was held to review the status of central and state government schemes in the district, the DC emphasised the need for "strict monitoring, constant supervision, and quality maintenance of the developmental works by all the executing agencies."

He drew the attention of the participants towards the importance of the Koyu-Goye road project, being executed by the PWD, which connects three districts – East Siang, Lower Siang and Leparada – and has vital strategic and economic importance.

The DC asked the district agriculture officer to "initiate the proposal for establishment of a Krishi Vigyan Kendra in the district on priority basis."

Rakshap also asked the EEs of all departments to "have parleys and consultations with the other line departments to prepare comprehensive DPRs, ensuring incorporation of all required components, so that projects don't encounter controversy at the implementation stages."

He said that the PRI members have important roles in formulation and implementation of schemes launched by the government. "They need to educate the people about the schemes and coordinate with the departments concerned," he said.

Local MLA and Deputy Speaker Kardo Nyicyor, speaking on the occasion, termed the agriculture and allied departments "the mainstay of the rural economy of the state."

Nyicyor said that the department should carry out proper survey and identify feasible projects "and also the best potential beneficiaries, involving the panchayat members, while preparing projects and selecting beneficiaries." Speaking on the requirement of infrastructure development in the district, Nyicyor said that "it shall be done once the official formalities for the district headquarters are completed."

"Siji shall be a model district headquarters with proper town planning and exemplary execution of the infrastructure development works," he observed.

Speaking on the efforts to improve the education sector in the district, he emphasised the idea of "pulling together the understaffed schools of the villages having poor infrastructures and resources to a centralised location, and providing it with the best possible infrastructures and teaching faculties."

He also mooted the idea of "proper exploration and identification of potential hydropower projects in the district to boost the economy, and at the same time to be self-sufficient in electricity."

Nari-Koyu MLA Tojir Kadu asked the officers to "disseminate information to the public on the developmental schemes launched by the government,so that the schemes reach the rightful beneficiaries."

DPDO Tajum Ronya asked the departments to identify the issues and problems being faced by them in implementing the projects, "so that the next DLMC meeting can focus on finding solutions to the problems."

Earlier, officials of the executing agencies delivered presentations on the achievements and progress of their ongoing projects.

The meeting was attended also by, among others, ZPC M Nguba, ZPMs, Lower Siang Galo Welfare Society unit president Senggo Taipodia, the EEs of all the works departments, and heads of offices.

Pul highlights huge potential in AP-OIL meet on geothermal and critical minerals exploration

ITANAGAR, July 12:

Arunachal Pradesh Science & Technology Minister Dasanglu Pul said that Arunachal offers "huge potential for geothermal energy as an alternative source of green energy to secure future energy needs of India, including critical minerals, which are still untapped, for its utilisation, "Itanagar-based Centre for Earth Sciences & Himalayan Studies (CES&HS).

Pul said this while chairing a high-profile meeting at the Oil India Ltd's (OIL) headquarters in Noida, UP, on July 12 in a significant move towards sustainable energy development.

Addressing the participants, including OIL Managing Director Dr Ranjit Rath and Pul's adviser Phurpa Tsering, she urged the OIL to "forge coordinated efforts and share expertise with the state government to successfully tap the geothermal energy potential of the region to enhance energy security," and advocated ensuring "sustainable development with a disaster management plan in place in the seismologically active northeastern part of India."

She assured the OIL team of the state government's support in exploring for geothermal energy," including natural oil and gas and critical minerals, which will propel the state's economic growth and development."

Dr Rath expressed keen interest to "invest in the exploration and production of untapped natural resources in Arunachal Pradesh," and informed that "the OIL has taken up a collaboration project with the BPCL and the HPCL to expand natural gas pipelines in Arunachal Pradesh, ensuring 24/7 supply to every household."

He emphasised that investment in exploration is crucial for sustained growth of the nation. "We are committed to making Arunachal Pradesh a revenue-generating state through the development of its vast natural resources," he added.

Tsering commended the OIL's initiative and emphasised the need for expert collaboration for the state's progress. He also acknowledged the OIL's CSR division "for its continuous support of various developmental projects."

OIL Executive Director (E&D) Saloma Yomdo stressed the importance of diversifying into geothermal energy and critical minerals exploration "as the company has expertise in exploration and production techniques."

CES&HS Director Tana Tage presented the details of "the findings and progress made during the recent investigation and feasibility studies of geothermal energy by the centre."

"In the findings, hot springs survey and investigation carried out in four districts, Tawang district shows promising potential for geothermal energy for generating electricity and other applications like space heating and cooling and drying of perishable food items," he said.

In response to this, Dr Rath suggested conducting a "reconnaissance survey jointly with the OIL and the National Centre for Seismology on the abandoned wells previously drilled by the OIL." National Centre for Seismology Director Dr OP Mishra, the OIL's chief general managers, its HR director, and other officials from the OIL and the CES&HS also participated in the meeting.

DC Visits Border Area Govt Secondary School

SOHA, July 12:

Tirap Deputy Commissioner Ira Singhal on July 12 visited the government secondary school (GSS) here in the district with the aim of enhancing the academic performance and future career prospects of the students of Soha area.

She was accompanied by DDSE KC Lowangcha, Soha CO Dingzang Baham, and staff of the DDSE office.

During a meeting with the school's headmaster, the village chief, GBs, PRI members, and students from Soha and nearby villages regarding "zero per cent results in the Class 10 CBSE exam 2023-'24," the DC directed the teaching staff and parents to "ensure that all teachers posted at GSS Soha must settle at their quarters by the coming Monday."

In a four-point directive, the DC further said that "parentsteachers-members meeting should be conducted within the next week of this month and remedial teaching should be conducted by the respective subject teacher after the completion of formal classes for weaker/slow-learner students, starting next week."

She said that morning assembly at the school must be completed before 9 am to ensure that classes start promptly at 9 am.

"Failure to comply with

the instructions within a week will result in issuance of suspension orders,"the DC warned.

During the meeting, it was also decided that the GSS' headmaster would submit a report on the implementation of the measures to the DC and the DDSE by 20 July.

Addressing the gathering, the DDSE advised the parents to cooperate fully to achieve better results in the CBSE examination.

A career counseling session was also conducted, enriching the students' understanding and inspiring them to explore new ideas for their futures.

Among others, Soha village chief Wangroi Lowang commended the DC and the DDSE for their efforts to improve the quality of education in the area.

Fisheries Summer Meet, 2024

Arunachal Minister seeks separate fisheries policy for Himalayan region

MADURAI, July 12:

Fisheries Minister Gabriel D. Wangsu has asked the centre to consider separate policy and schemes for the Himalayan states saying that the needs and topography in these states are completely different from the rest of India. The centre also may like to revisit and revise the unit cost of all construction works considering the high cost index and remoteness, he added.

The minister was addressing the Fisheries Summer Meet, 2024 at Madurai in Tamil Nadu on June 12 which was attended by Union Minister for Fisheries Dr. Rajiv Ranjan Singh, Ministers of State Dr. SP Baghel and George Kurien besides Fisheries ministers from various states, top officials from the Govt of India and state governments/UTs.

Stating that Arunachal Pradesh is one of the pioneer states in cold water fisheries in the entire North Eastern India, Wangsu demanded a substation of Directorate of Coldwater Fish Research to fulfill the need for proper R&D facilities for documentation of breeding and culture protocol of these species of fishes available in the state.

"Arunachal Pradesh is a power house of the country and more and more hydropower stations are coming up, thereby creating large water bodies which can be judiciously exploited for fish production in mass scale", the minister said while seeking a comprehensive technology package for its integrated development and management with adequate financial support.

Addressing the day-long function he also sought mapping of resources employing geospatial techniques for preparing resource inventory and optimum utilization, and one time grant for strengthening, and up-gradation of existing seed producing infrastructure of both cold and warm water calibrating to its optimum capacity so as to overcome recurring shortage of quality seed in desired quantity.

"In-situ conservation of indigenous germplasm of fish species is a big challenge because of heightened anthropogenic activities, habitat degradation and destruction coupled with adverse effect of climate change. Our open water systems are fast dwindling and are on the verge of extinction", the minister pointed out and advocated for a comprehensive package with adequate financial support for propagation and mass awareness to save these precious wealth.

"Since working period is limited because of long rainy season, rationalization of subsidy from the current four instalments to two equal instalments against all schemes shall definitely expedite perfect implementation of the schemes and timely utilization of fund", he observed. He further requested the Centre for extension of PMMSY scheme for another 2 years with additional fund and launch new scheme to compensate against for the loss caused due to delinking fisheries from RKVY scheme.

Impressed by the short video on the Integrated Aqua Park of Ziro screened at the Summer Meet, the Union Minister RR Singh expressed his desire to visit Arunachal Pradesh and personally take stock of all fishery related developments in the state. While summarizing today's proceedings Singh assured all out support to the states in addressing respective concerns and make India a prominent nation in fishery sector.

The Joint Secretary in the ministry Sagar Mehra, later addressing the meet informed that, the ministry would initiate for making payments against central schemes in 2 instalments instead of four. Revision of unit cost of all constructions in the Himalayan states too would be considered in new central scheme. he observed and informed that proposals for brood banks and hatcheries from states would be attended to with due diligence. Report quoting sources in the Fishery Ministry said senior officials at the Centre have taken note of the issues raised by the Arunachal Minister and that the Centre would address these concerns in coming days.

Sensitization programme on legal services held

ITANAGAR, July 13:

A one-day sensitization programme on legal services for disaster victims, new criminal laws, and women's schemes was organized by the District Legal Services Authority, Yupia, Papum Pare District, in collaboration with the Arunachal Pradesh Women's Welfare Society and the One Stop Centre, Itanagar, Papum Pare District, on July 13, 2024, at Lor Potung Village, Papum Pare District.

Advocate Taying Nega, Legal Aid Counsel, informed attendees about the role of the Legal Services Authority for disaster victims, explained how people can avail themselves of its benefits, and discussed Legal Aid and the Arunachal Pradesh Victim's Compensation Scheme. Advocate Nada Nampi deliberated on the new criminal laws, and Advocate Ribbom Riba explained how to access the One Stop Centre and Women Helpline Services, along with various women's schemes under the Department of Women and Child Development. She expressed satisfaction with the programme, noting its necessity as many were unaware of how to access legal services during disasters and various women's schemes. The team provided participants with contact numbers for necessary assistance.

Cabinet approves bill to ensure probity in recruitment exams

The State Cabinet that met on July 15 under Chief Minister Pema Khandu made several landmark decisions. Pradesh Examination (Measures for Prevention of Unfair Means in Recruitment) Act 2024" in order to prevent and curb the offences related to leakage of question papers and other malpractices during the recruitment examinations conducted by various recruitment agencies.

The draft bill which incorporates stringent penalties and imprisonment with imposition of fine up to one crore shall be tabled in the ensuing second session of the 8thArunachal Pradesh Legislative Assembly commencing from 19th July next for discussion and passage of the same. The bill after becoming an Act will ensure free and fair selection process of all posts under the Government of Arunachal Pradesh and detect mal practices.

The Cabinet further approved the proposal for encadrement of 13 various categories of posts of Arunachal Pradesh Staff Selection Board (APSSB) into common cadre of Arunachal Pradesh Civil Service and Arunachal Pradesh Secretariat Service Common Cadre. This move was necessitated to bring proper and systematic human resource management in the APSSB for free and fair recruitment process. It is

CM held meeting with CBOs

ITANAGAR, July 16:

Chief Minister Pema Khandu has called upon the state's Community Based Organizations (CBOs) to suggest, cooperate and assist the state government in realizing the goal for self-sustenance, to multiply stateowned resources and turn resources into revenue.

In his opening remarks during the pre-budget consultative meeting with CBOs at CMO on July 16, Khandu said that the CBOs representing all the communities of the state have in the past put in valuable suggestions, especially in health and education sectors, which the government considered and incorporated in the state's annual budgets reaping rich dividends.

He pointed that based on the government's commitment for inclusive governance, pre-budget consultative meetings form the core around which the state budget is prepared.

To convert resources into revenue, Khandu highlighted two sectors – hydropower and tourism – which, he said, can be tapped systemically to enhance the pool of state-owned resources.

He, however, made it clear that all hydropower projects in consideration will be implemented only with consent of the local communities.

"Yes, hydropower is our best bet to revenue generation. Our annual revenue, which is about Rs 500 crore at the moment can soar to more than Rs 1000 crore in the next 5-10 years if all the proposed hydropower projects are executed successfully. But no, no project will be implemented without the consent of local communities," he said.

He informed that MoUs have been signed only with reputed

central government agencies that include, NHPC, NEEPCO, NTPC and SJVN by doing away with private and unreliable companies and firms.

Khandu urged the CBOs to communicate the benefits of tapping the state's massive hydropower potential that can make Arunachal Pradesh a self-sustainable state to their respective community members.

The other sector that can be a gamechanger for Arunachal Pradesh according to Khandu is tourism. He though strongly pushed for ensuring high-end tourism.

"With the ILP system in place and a proper policy we can easily control and regulate the tourism sector that would benefit the local communities, generate income for youths and contribute to the state-owned pool of resources while keeping our environment intact," he said.

Khandu cited the tourism policy followed by neighbouring country Bhutan, which too solely depends upon tourism and hydropower, and said that a similar policy can be implemented here in Arunachal Pradesh.

He urged the CBOs to encourage their community members to invest in home stays and if possible in high-end hotels to attract high-end tourists.

Meanwhile, Khandu drew attention of the CBOs towards the malice of money-for-vote culture that were rampant in the recently concluded Assembly and General Elections in few constituencies.

"I have been time and again campaigning for the end of money culture in elections but in vain. I have reports with me on use of huge money to influence voters in some of the assembly constituencies. CBOs have to raise to the occasion if we want to end corruption for I have been continuously saying corruption begins when one gives or takes money in exchange of votes," Khandu said.

He expressed gratitude to the CBOs for their constant support and insightful feedbacks.

"Your voices have shaped our budget, ensuring every community in Arunachal Pradesh is heard and their concerns addressed. Through this collaborative spirit, we've incorporated many invaluable suggestions, driving inclusive growth and sustainable development," Khandu added.

Committee to be established to develop new Industrial Policy; Dukam

CM urges for more flight connectivity from Donyi Polo Airport

ITANAGAR, July 17:

Arunachal Pradesh Chief Minister Pema Khandu has requested the Union Civil Aviation Ministry to increase flight connectivity to and from the Donyi Polo Airport, Itanagar for improvement of quality of life of citizens, connectivity, tourism and commerce in the state.

In a letter (DO.No.CM (ARUN)-07/2024-25/16th July 2024) addressed to Union Civil Aviation Minister KinjarapuRammohan Naidu dispatched Tuesday, July 17 Khandu pointed that as of now, one flight each is being operated to and from the Donyi Polo Airport to Kolkata (6 times a week) and New Delhi (4 times a week).

These flights, he said, are regularly operating at complete capacity, often leading to immense surges in travel fares and unavailability of tickets for prospective passengers, including in cases of medical and other exigencies. Also the absence of daily flight operations hampers ease of access for visitors, tourists, etc., often forcing them to seek other travel options.

Khandu further pointed that connectivity options through connecting flights to major cities from the Kolkata and New Delhi airports is poor. To prove his point, he cited that there is no same-day connectivity while travelling from Itanagar to Bhopal and Kochi, causing passengers to spend an additional night at New Delhi or Kolkata, the layover while travelling from Itanagar to Ahmedabad is 5 hrs. 25 min, while returning from Ahmedabad to Itanagar is 4 hrs. 40 min and the layover while travelling from Itanagar to Bengaluru is 6 hours

The Chief Minister also lamented the discontinuation of flight services between Itanagar and Guwahati operated by FlyBig under the UDAN scheme since November 2023.

He appealed the Union Minister to increaseflight services from Itanagar to New Delhi and Kolkata, preferably including an additional morning departure from Itanagar to New Delhi, daily operations of flights from Itanagar to New Delhi, direct flight connectivity to other major Metros such as Bengaluru, Chennai, Mumbai, Hyderabad, etc, improvement of connectivity options from New Delhi and Kolkata Airports for connections to major cities and reinstating flight services between Itanagar and Guwahati under the **RCS-UDAN** scheme.

Meanwhile in another letter directed to Rahul Bhatia, Group Managing Director of InterGlobe Aviation Limited (IndiGo), Khandusought increase in number of flights to Delhi, pref-

erably a morning departure flight from Itanagar. He also requested for direct flight connectivity from Itanagar to other major Metros such as Bengaluru, Chennai, Mumbai, Hyderabad etc.

Expressing gratitude to IndiGo for operating the first flight from the Donyi Polo Airport, and for connecting Itanagar to Kolkata and New Delhi through regular flights, Khandu said thatthe initiation has been of immense comfort and convenience to people of Arunachal Pradesh and other States, tourists, students and others.

He informed that the State's department of Civil Aviationhas already been instructed provide all necessary support to IndiGo for the enhancement and extension of flight services.

It may be noted that IndiGo has announced to operate flight services between Itanagar and Kolkata 7 days a week starting July 31. Currently there's no flight service on the route on Wednesdays.

"Make horticulture a working and resultoriented department"- Wangsu

The newly inducted members include Land Management Minister Balo Raja as Chairman and 14 Doimukh MLA Nabam Vivek, Rajya Sabha MP Nabam Rebia, Papum Pare DC Jiken Bomjen and SP Taru Gusar as members. Addressing the administrative officers present in the meeting 14 Doimukh MLA Nabam Vivek, while highlighting the significance of understanding on-the-ground conditions to address border related challenges said that "Accurate and up-to date information is vital for informed decision – making. By assessing the ground realities, we can develop targeted solutions that address 'area specific 'causes of border issues".

He further asked all the Administrative officers for completing a reviewed field assessments of the border areas by the end of August, 2024 and also proposed for meetings with the Chairman and the Assam counterpart in September, 2024.

He also suggested for better coordination among the elected representatives, Administration, Police & Forest on the boundary issues.

DC PapumPare Jiken Bomjen called for maintaining status quo at the border areas and avoiding provocative actions at all cost.

He briefed about the present status of the border issues with Lakhimpur and Sonitpur Districts of Assam with Papum Pare and also highlighted the action takens on the boundary issues of the previous meetings.

DC ensures protection of every child from Vaccine-preventable diseases

PASIGHAT, July 19:

East Siang Deputy Commissioner Tayi Taggu on July 19 called for 100 percent immunisation coverage in every health centre of the district, in order to ensure that "every child is protected from vaccine preventable diseases."

The DC was addressing a review meeting on the district task force for immuni-sation's routine immuni-sation (RI) coverage during the first quarter of this year.

DMO Dr Komling Perme stressed on carrying out proper household surveys in the villages and the urban areas "as the basis for successful implementation of the micro-plan for RI." Dr Perme also called for "proactive efforts to cover floating population under the immunisation programme."

"All health centres must be prepared for National Quality Assurance Standards (NQAS) certification to meet the 50 per cent target by 2025 and 100 per cent NQAS certification of health facilities, covering the district hospital, PHCs, CHCs and UPHCs by 2026," the DMO said.

The meeting also highlighted the requirement of ASHAs as ASHAs are overburdened in the urban health centres.

DRCHO Dr N Angu delivered a presentation highlighting the status of the RI, and measles and rubella immunisation at the PHCs in Ruksin, Mebo and Pasighat blocks, BPGH, and the FRU in Ruksin.

Dr Angu also highlighted "the award of quality certification of HWCs of Berung and the FRU of Ruksin under NQAS and Laqshya programme."

WHO RRT & routine immunisation consultant Dr Aishwarya RG shared inputs for strengthening RI in rural and urban areas.

3 bills introduced in Assembly on first day of budget session

ITANAGAR, July 19:

The Budget session of the 8th Arunachal Pradesh Legislative Assembly kick started on Thursday, July 19 here at the state Legislative Assembly.

The first day of the Budget Session saw the introduction of 3 key bills of the state government for the consideration by the assembly. Chief Minister Pema Khandu introduced the Arunachal Pradesh Public Examination (measures to prevent Unfair means in Recruitment) Bill, 2024, in order to prevent and curb offenses related to leakage of question papers and other malpractices during the recruitment examinations conducted by various recruiting agencies.

The Arunachal Pradesh Amending Bill, 2024 was introduced by Kento Jini Minister of Law, Legislative and Justice, Social Justice, Empowerment & Tribal Affairs, Sports and Youth Affairs.

The Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulations (Amendment) Bill, 2024 was also introduced by Balo Raja, Minister of Urban Development, Town Planning, Urban Local Bodies, Housing, Land Management and Civil Aviation.

The house also discussion on motion of thanks to Governor's address, moved by Mutchu Mithi, MLA Roing, and seconded by Jikke Tako, MLA Tali Kra Daadi.

Mithi while expressing his gratitude to the Governor for the support to the government appreciated the state government for the efficient and effective execution and implementation of various developmental activities. He also lauded the government for equitable and equal distribution of resources.

Expressing concern over the under-construction mega dam by China near Arunachal Pradesh, BJP MLA Ninong Ering urged the government to take up the issue with the Centre.

China is building a 60,000 megawatt dam on the Yarlung Tsangpo River in Medog, near the international border. Tsangpo is known as Siang in Arunachal and Brahmaputra in Assam. The main channel of this river is the Jamuna, which flows through Bangladesh before joining the Bay of Bengal.

Participating in the motion of thanks to the governor's address in the Assembly, Ering said, "We cannot trust our neighbour. You never know what they can do. They can either divert the entire river flow, drying up our Siang, or release water at once, causing unprecedented floods havoc downstream."

He added that not just India, but the construction of the dam might also affect Bangladesh.

"People's safety and country's security cannot be compromised. Our motto should be 'nation first' and we have to think for India's security," the former minister of state for minority affairs said.

While supporting construction of dams with storage capacity to check floods in the region, the MLA from Pasighat West Assembly constituency informed that there is no water treaty between India and China so far.

Referring to the opposition by anti-dam protagonists, the lawmaker suggested that they should be consulted before constructing dams, so that the interest of the people is looked into.

"Hydropower is Arunachal Pradesh' only resource," he added.

Senior MLA,Borduria-Bogapani Wanglin Lowangdong, apprised the government on prevailing problem of unemployment, facts on the lacunae in the education system like shortage of basic infrastructure and hu-

She advised the women participants to take advantage of women centric central/state schemes.

"Beti Bachao Beti Padhao is a central scheme especially launched to save the girl child and educate them," she further added and exhorted all to report any form of violence against women or girl child even within the family or amongst relatives.

Also while highlighting provisions under Protection of children from Sexual Offence Act 2012 (POCSO), Domestic Violence Act 2005, DD Taba added that "Police and other agencies are mandated to protect and help the victims," and urged all to seek assistance from the concern authorities by dialling Child Help Line 1098 which is available for 24×7 as and when required.

Dr Minge Tato Tana, M.O I/C, CHC Balijan also attended the program. Dr. Tana highlighted the importance of breastfeeding, infant care and also dwelt on maintenance of personal hygiene of lactating mothers and Child.

She also briefed about the importance of timely vaccination of infants and other vaccines required in a lifetime.

The program ended with distribution of gift hampers to the mothers present.

Anganwadi workers, Ashas and women from the nearby areas attended the program.

Assembly passes Balipara, Tirap, Sadiya Frontier Tract Jhum Land Regulation (Amendment) bill

ITANAGAR, July 22:

The Balipara/ Tirap/ Sadiya Frontier Tract Jhum Land Regulations (Amendment) bill 2024 was passed unanimously in the house on the second day of the budget session. The bill was earlier moved by Minister of Urban Development, town planning, urban local bodies.etc Balo Raja here on Monday, July 22

The Bill mainly aims at the amendment of section 10 of the Jhum Land Regulations Act 1947. This Bill tries to streamline the land acquisition process which would help in clearing out the disparity in compensation, shorten the time for land acquisition and lead to enhancement of revenue generation in the form of land revenue. The Bill also aims at strengthening, preserving and protecting the customary rights over land of the people of the state. Till now the JLR Act 1947 is being followed according to which the land acquisition is done by providing "reasonable compensation". However, there was no clear cut definition or mechanism for calculating the "reasonable rate" of compensation in the JLR Act 1947. Hence, the compensation is calculated and provided at different rates as per the interpretation of the acquiring companies and as deemed fit by the concerned Deputy Commissioner. Hence, the bill aims at changing the present system of land acquisition process. **Question hour**

Chief Minister, Pema Khandu informed the House, that development is priority for the government therefore, for socio economic upliftment of the concerned area, multilateral road was constructed on Monday, July 22 while answering to question put forward by the NPP MLALongding -Pumao, Thangwang Wangham about the reason as to why the government had the dire need to construct new additional road between Senua and VKV Longding involving huge amount of the government fund whereas there is already a shorter road connecting these 2 places, the state Chief Minister and Minister of Public Works Department,

Deputy Chief Minister Chowna Mein informed that the government has so far terminated 53 Memoranda of Agreements (MoAs) after issuing show cause notices to private power developers. DCM was responding to Congress MLA Kumar Waii's starred question regarding the status of hydro power MoAs with power developers.

"The State Govt has terminated 53 MoAs after issuing show cause/intent to terminate notices, due to the failure of the companies to commence implementation on time. Out of the total terminated projects, 11 projects have been allotted to interested developers, including Central Public Sector Undertakings (CPSUs)," DCM said in response to Waii, adding that the government is considering terminating MoAs with non-serious and underperforming developers.

DCM further informed that the remaining 42 projects will be re-allotted to interested developers. The government has issued show cause notices/intent to terminate notices to 73 developers due to their failure to commence project implementation. "If the developers' replies are not satisfactory, their MoAs will be terminated," he added.

The DCM also informed the house that on August 12, 2023, MoAs for 12 projects were signed in the presence of the Union Power Minister with CPSUs. The total installed capacity of these 12 projects is 12,723 Megawatts, with an investment of Rs. 1,35,360 crores.

"It is a pleasure to inform the house that the Dibang multipurpose project has commenced construction activities at the project site. The project is being executed in mission mode and is expected to be completed by 2032. As of June 30, 2024, the project has achieved an overall physical progress of 12.22%," DCM said.

He added that the state government is conducting regular review meetings with developers to ensure sustainable economic development, timely project completion, increased power generation, and accelerated project progress.

Waii had sought details on the total number of MoUs and MoAs for power project development in Arunachal Pradesh that have been terminated or withdrawn. He also inquired about the government's actions against defaulting developers.

The Deputy Chief Minister further explained that the delay in implementing the power grid project in Changlang district is due to issues with forest clearance, working permissions, and right-of-way clearances. He responded to Nampong MLA Laisam Simai's starred question on the reasons for the delay, affirming that Changlang district will be connected to the power grid by 2025.

Home minister Mama Natung informed that all the notified Women Police Stations (WPS) across the state will be made func-

tional in phases. The home minister was responding to Borduria-Bogapani MLA WanglinLowangdong's starred question regarding WPS Khonsa.

Natung added that 21 WPS were notified under Chief Minister Pema Khandu's government in 2018 to address women-related issues. However, due to the Covid pandemic, only seven WPSs – Tawang, Seppa, Itanagar, Ziro, Aalo, Pasighat and Tezu – were able to become functional.

He also mentioned that the lack of required infrastructure, other necessary components, and delays in sanctioning manpower were factors contributing to the non-functioning of the remaining 14 notified WPSs. He assured the house that the remaining WPSs would be made functional in phases.

Lowangdong argued that the Tirap, Changlang and Longding belt have witnessed numerous women-related crimes. He cited the recent custodial death of a woman prisoner in Changlang, attributing it to the absence of a separate women's police station.

"In the TCL belt, there are many cases related to women, such as narcotic substance cases. I seek a precise answer from the government instead of mere assurances," said Lowangdong.

Kumar Waii, MLA INC, reiterated that to bring about quality education the right to education must be abolished. The number of schools must be minimized and the existing ones should be provided with complete required human resource and infrastructure. He also urged the government to make provisions for the regularization of SSA teachers and to transfer them to different districts based on needs. He requested the government to make a system of promotion or to give allowance to teachers and police personnel on merit basis. He emphasized on transparent and people friendly government.

The House also continued with the discussion on motion of thanks' to the Governor's address..

Chief Minister Pema Khandu, reiterated his commitment to ensuring equitable distribution of development funds across all districts. Participating in the 'motion of thanks' to the Governor's address delivered in the first session of the Eight Legislative Assembly on June 15, the CM said suggestions put by various members irrespective of party affiliations would be honoured by the state government. He emphasised the crucial role of connectivity in the state's development journey, aiming to achieve a 'Viksit Arunachal' by 2047, aligning with Prime Minister Narendra Modi's vision for a prosperous India.

Highlighting significant strides in overcoming communication challenges such as road, air, railway, and digital connectivity, Khandu credited these advancements to sustained attention from the central government. He acknowledged connectivity as a historical impediment to development and noted that since assuming office in July 2016, his administration has prioritised enhancing infrastructure.

Looking ahead, Khandu outlined ambitious plans to connect all remaining villages in Arunachal Pradesh with road and mobile networks within the next five years. He cited a nine-fold increase in road construction pace over the past eight years and a 143 per cent expansion of the state's national highway network due to initiatives spearheaded by Modi. In terms of tourism, Khandu reported a remarkable 141 per cent rise in domestic tourist visits and a 36 per cent increase in foreign tourist arrivals. In healthcare, over 7 lakh people have benefited from the Chief Minister Aroygya Arunachal Yojana (CMAAY), while one lakh women have been connected to various schemes through self-help groups. Additionally, more than 20,000 farmers have been supported under schemes promoting selfreliant agriculture, he added.

Advocating for a development framework anchored in transparency and accountability, Khandu encouraged proactive participation from legislators across party lines to achieve a robust Gross State Happiness Index.

Taking part in the discussion, lone Congress member Kumar Waii suggested a change in the state's land policy by giving ownership to people so that seeking finance to start business from banks by people could be made easier.

PPA legislator Nabam Vivek suggested the government for prioritising the health and education sectors while Independent member Laisam Simai suggested for including the Indo-Myanmar border under the Centre's ambitious vibrant village programme in the state.

Private Member's resolution

Toko Tatung, MLA Yachulimoved the private member's resolution for the government of Arunachal Pradesh to take a steps to introduce the state Nursery Act which will basically help in producing quality plant material. This Act is to ensure availability and supply of genuine planting material for farmers.

Tatung informed the house that this Act will allow the state to generate employment and revenue for the state. It will help in keeping

a check on the quality of cash crop saplingsbeing brought into the state and will help in good quality produce.

Obituary reference

The Arunachal Pradesh Legislative Assembly paid tribute to former Power and PWD minister TaloMugli, who passed away on July 18th after a prolonged illness at Raga in Kamle district. Members of the Legislative Assembly remembered the contributions made by the former minister during his illustrious political career. The house observed two minutes of silence as a mark of respect to late Mugli.

Taking part in the obituary reference, Deputy Chief Minister Chowna Mein recalled the significant contributions of late Mugli in the socio-cultural promotion of the Nyishi community, his efforts in indigenous faith and cultural movements. "Whatever he did for Arunachal will always be cherished," said DCM. "Though Talo-Mugli is no longer with us today, his friendship and the moments we spent together in the service of the state will be cherished forever," Mein added with a poignant tone.

Legislative Assembly Speaker TesamPongte conveyed condolences on behalf of the house to the bereaved family members. "On behalf of the sixty honorable members and myself, I would like to convey condolences to the bereaved family members. I pray to almighty gods Rangfra, Syi-Donyi, and Donyi-Polo for the eternal peace of the departed soul of Talo-Mugliji and strength for the family members," said the Speaker.

Home minister Mama Natung, in his address, fondly remembered late Mugli for his contributions in shaping Nyishi society. "He was always a guiding and fatherly figure. He rose from grassroots to the ministerial level. Today, it's a sad moment that we lost such a towering leader of our state. In this hour of grief, I, on behalf of my entire constituency and myself, convey heartfelt condolences to the family of late TaloMugli. My prayers and thoughts are with them," said Natung.

"He was himself an institution and an inspirational figure. He was an eloquent speaker who captivated listeners through his speeches," said minister of commerce, industries, and IPR Nyato Dukam, while remembering late Mugli.

Congress MLA Kumar Waii praised late Mugli for his exuberant energy in games and sports and his role in Nyishi unification. Former minister HonchunNgandam and legislators Pani Taram, Jikke Tako, RotomTebin, Tania Soki and Tojir Kadu also participated in the obituary reference.

Prevention of unfair means in recruitment gets overwhelming support

ITANAGAR, July 23:

The Arunachal Pradesh Legislative Assembly passed two bills on Tuesday, July 23: the Arunachal Pradesh Amending Bill 2024 and the Arunachal Pradesh Public Examination (Measures for Prevention of Unfair Means in Recruitment) Bill 2024.

The Prevention of Unfair Means in Recruitment Bill received thunderous support from legislators of all parties, with many praising Chief Minister Pema Khandu for introducing this muchneeded legislation to safeguard future generations from malpractices and unfair means in state competitive examinations. In tabling the bill for consideration, Chief Minister Pema Khandu thanked legislators for their active participation in the discussions. "Your active participation in the discussions has been instrumental in advancing these important reforms. Together, we remain committed to working towards a more transparent, fair, and progressive governance framework in our state," CM Khandu exhorted.

CM Khandu referred to the paper leakage fiasco in the Arunachal Pradesh Public Service Commission incident as reflecting our societal mindset and a collective failure of the state. He called for a change in societal mindset, stating, "No matter how strong a law we enact, no law can provide foolproof security until and unless society changes its mindset," appealing to society to change its mindset towards such malpractices in competitive examinations.

"Through this bill, the government aims to enact stringent laws to deal with offenders. This bill comprises five chapters with 27 sections. The act imposes stringent penalties for offenses related to impersonation, leakages, and malpractices in Chapter II of the act," he informed the house.

"As per Section 11, all offenses under this Act shall be cognizable, non-bailable, and non-compoundable," CM added.

When members suggested increasing penalties from Rs 1 crore to Rs 5 crore and increasing imprisonment terms from three years to life imprisonment, the Chief Minister clarified that the proposed bill includes more stringent sections and clauses than any state and central acts regarding preventive measures against unfair means.

He informed the house that while the central act provides for a penalty of Rs 10 lakhs, the proposed bill proposes a penalty of Rs 1 crore. The central act lacks a debarment clause in case of offense; however, under Section 14 of the bill, an examinee convicted of an offense under this act shall be debarred from taking any future public examinations.

He also noted that the central act does not mention a redressal cell or a high-level inquiry committee, whereas the proposed bill includes both. "However, since members have suggested that the penalty amount should be increased and more stringent clauses added, our intention is clear. All 60 members and the younger generation want this Act to be introduced to deal with such malpractices. The Advocate General will be consulted for amendments if necessary," CM added.

Law, Legislative, and Justice Minister Kento Jini informed the house that the Arunachal Pradesh Amending Bill 2024 was necessitated in the Assembly due to the repealment or replacement of three major acts: the Indian Penal Code (IPC), the Criminal Procedure Code (CrPC), and the Indian Evidence Act (IEA) in parliament.

"The new laws introduced include the Bharatiya Nyaya Sanhita (BNS) replacing the IPC 1860, Bharatiya Nagarik Suraksha Sanhita (BNSS) 2023 replacing the CrPC 1899/98/1973, and Bharatiya Sakshya Adhiniyam (BSA) 2023 replacing the IEA 1872," the minister informed.

"These three central laws introduced in 2023 represent a significant overhaul of India's criminal justice and judicial delivery system, replacing colonial-era legislations. Due to the replacement of these three central laws, we have brought forth the present Amending Bill 2024, amending a total of 49 local laws," Jini said.

Question Hour

Arunachal government to install AI-based CCTV cameras in 22 check gates

Arunachal Pradesh home minister Mama Natung said the state government is contemplating to install AI-based CCTV cameras in 22 check gates of the state to ensure that no unwanted elements and restricted items pass through such gates along the inter-state boundary.

Responding to a question by NCP member Likha Soni during question hour in the Assembly, the minister informed that all the 30 check gates are currently under stringent supervision to prevent the entry of undesirable social elements and drugs.

"The government is always committed in ensuring proper facilities at the check gates for the safety of people and the state," the minister said.

Responding to a supplementary question from the MLA regarding the current condition of the Dirak check gate in Namsai district, which is also a gateway to several other districts in the state, Natung informed that it was operational since 1989 and is running with proper infrastructure facilities.

"There are three sentry posts at the gate out of which two are managed by CRPF and one by state police. CCTV cameras have been installed for proper surveillance," Natung said.

Responding to another question by NPP MLA Thangwang Wangham regarding lack of infrastructure at the police station at Pumao circle in Longding district bordering Nagaland, the minister said the police station was notified as C class in 1989 and infrastructure upgrade for the outpost could not be taken up because of nonavailability of allotted land to the home department.

"The state government is aware of the situation as instances of movement of anti-social elements from Nagaland have been reported on several occasions," Natung said and added that proposal for infrastructure development is under consideration of the government.

The home minister informed that the state Cabinet last year sanctioned 3,000 posts of police personnel and once the recruitment process is completed, manpower requirement in many police stations in the state would be fulfilled.

Arunachal Pradesh is placed among the top four states in the country for all categories of substance abuse informed Health and Gamily Welfare Minister Biyuram Wahge the house while responding to a question by senior BJP member Wanglin Lowangdong, said that according to a survey, the magnitude of substance use in the northeastern state is 'alarming, the Minister added.

The survey examined the extent and pattern of use of eight categories of psychoactive substances – alcohol, cannabis, opioids, cocaine, amphetamine stimulants, sedatives, inhalants and hallucinogens – and found that Arunachal Pradesh is among the top four states in India, the minister said.

He added that opium cultivation has been in practice among several tribes of the state for centuries while poppy cultivation and opium consumption have been deeply ingrained in the socio-economic and cultural life of the peo-

ple in the eastern part of Arunachal Pradesh.

"A report by the Central Narcotics Control Bureau (NCB) warns of large-scale commercial cultivation of poppy in the state. The report emphasised the urgent need for intervention to prevent adverse impact on national security, and the health and survival of various tribes inhabiting remote and inaccessible areas of the state," Wahge said.

The unchecked spread of addiction among the young population could potentially result in the extinction of the communities; the minister added quoting the NCP report.

He said that in response to the challenges, the state cabinet had approved the policy on psychoactive substances 2021 which aimed at, inter alia, eradicating the use of psychoactive substances in the community, emphasising the need for primary prevention programmes and forming guidelines for regulating all demands.

The state government also created the Arunachal Pradesh Drug De-Addiction Society (AP-DDS) under the Chief Minister's flagship programme – Mukhya Mantri Nasha Mukhti Abhiyan (MMNMA) and has undertaken several activities to combat substance abuse, Wahge said.

The government has also opened several drug de-addictions-cum-rehabilitation centres across the state involving both government healthcare facilities and NGOs, the minister said.

"So far seven district hospitals in Anjaw, Changlang, Dibang Valley, Namsai, Tirap, West Kameng and Upper Siang have been identified for setting up addiction treatment facilities," Wahge said.

Plans are also in place to provide opium substitution thera-

py (OST) across 14 districts with existing facilities and conduct regular screening of government employees and community members. (News credit Arunachal Times & PTI)

Budget Estimate for 2024-25 Tabled

Focus is on health, education, and infrastructure

ITANAGAR, July 24:

The Budget Estimates and the Financial Statement for the year 2024-25 was presented by Chowna mein, Deputy Chief Minister & Minister – in – Charge of Finance on Wednesday, July 24.

Mein presented a Rs. 993.08-crore deficit budget, with a 2.08 percent Gross State Domestic Product (GSDP) target for 2024-25. The budget focuses on three major pillars: healthy human resources, robust infrastructure, and a vibrant economy centered around an enabling ecosystem of good governance and secure governance.

Presenting the budget in the house, DCM, who is also the finance and planning minister, stated, "The budget estimate is pegged at Rs. 35,840.79 crore, a 20.85 percent increase over the 2023-24 figure. I am delighted to inform you that we have achieved an impressive 186 percent expansion in the State Budget over the past nine years, reaching Rs. 35,840.79 Cr in BE 24-25. The Revised Estimate (RE) for the last fiscal year 2023-24 reflects a steady rise in our growth trajectory, paving the way for even greater outcomes by the end of the current fiscal year."

The DCM added that the state has witnessed unprecedented economic growth, resulting in a 135 percent rise in GSDP and a 105 percent increase in per capita income.

"In this budget, I shall focus on three pillars: healthy human resources, robust infrastructure, and a vibrant economy centered around the enabling ecosystem of good governance and a secure environment," Mein said.

Focusing on human resources, the minister of finance and planning allocated Rs. 2,139 crore for the education sector under Arun Shri Mission. This includes infrastructure buildings, education conclaves, integrated inventory assessment, and management systems for all government schools.

The Deputy Chief Minister declared 2024-25 as the "Year of Youth and Youth Aspiration," allocating Rs. 100 crore towards various activities to empower and fulfill the aspirations of the youth. These include a holistic and inclusive approach across various sectors focusing on health, education, skill upgrading, tourism and sports, among others.

Stressing on the health sector in Arunachal, the finance minister allocated Rs. 709 crore for investment. "We aim to build a high-quality and affordable healthcare system for all citizens," he said.

For the empowerment of women, the government allocated Rs. 372 crore for projects covering activities related to women and child development. The government also announced plans to construct 200 pink toilets across all districts, marking a significant step towards improving sanitation facilities for women.

In infrastructure development, the minister earmarked Rs.1,827 crore for the public works department and Rs. 830 crore for rural development.

To boost agriculture and allied sectors, the minister announced Rs. 621 crore. "Our agricultural goals include increasing the area under cultivation, enhancing productivity, improving remuneration for farmers, and boosting exports," he announced.

For the augmentation and upgrade of power department infrastructure, the minister allocated Rs. 337 crore, and Rs. 287 crore for various initiatives in home correctional and fire services. The resolution on de-reservation of forest area where developmental activities are being hampered and human settlements are already there in order to boost the developmental activities in the region. He informed the house that because of the reservation of various areas in capital region and other areas in the district, the general public is facing problem in renewal of allotment order, mortgaging of one's own land, etc. He said the reason behind this issue was because of The Forest Conservation Act 1980 significantly limited the powers of the state governments to notify and occupy forest land for development purposes and restricted the state governments from issuing further notification for the expansion of the state capital thus halting any plan and anticipated expansion. Therefore, the hands of the government are tied in this respect by law and the government cannot undo this Act and without the order of the Supreme



government also proposed Rs. 112 crore for the department of social justice empowerment and tribal affairs, and Rs. 61 crore for the department of indigenous affairs for the preservation, protection, and promotion of indigenous legacy.

Meanwhile, the department of planning felicitated winners of the three best suggestions of Jan Bhagidari 2024-25. The first prize was awarded to the Youth Mission for Clean River – "Revitalizing our rivers," followed by the Arunachal Pradesh Women Welfare Society for "Gender Empowerment and Supporting Women's Welfare," and Boken Jempen for his initiative on Clean and Green Environment.

Private Member's Resolution

Toko Tatung, MLA, Yachuli Lower Subansiri moved a the lack of consultation with the natives in such matters.

Replying to Tatung, Minister of Environment and Forest, Wangki Lowang said that the problem has already been taken up by the government. An empowered Committee had already been constituted in this regard to examine the interlocutory application file with respect to the de reservation of forest land in the state. The interlocutory Application (IA) has been prepared and submitted for approval and the file is currently under review for vetting by the Law department. And the Land Management department would file the IA in the Supreme Court for de reservation of areas in the capital region, Namsai, Deomali and Bhalukpong.

Court there cannot be any more de reservation and regularization of habitation in forest sanctuaries and national parks.

Question hour:

Replying to a supplementary question raised by MLA Wanglin Lowangdong, regarding the Shortage of Administrative Officers in Tirap district, Chief Minister, Pema Khandu said that due to the APPSC fiasco, there had been no appointments of entry grade and lateral entry admin officers for the last 2-3 years. Therefore, out of the 230 sanctioned posts of circle officers, only 130 posts are occupied leaving a huge gap of 106 Officers. Out of the 17 posts that were sanctioned for Tirap district only eight posts have been posted in the district till date. CM assured

that recruitment process would start soon as the Commission for the same was also in place now.

Earlier. the Education Minister PD Sona said, "Let's have a composite and comprehensive school environment" while informing the house that about 600 numbers of Schools that are not functioning have been closed down to equally distribute and streamline the funds and infrastructure in the other functioning schools. He was responding to a supplementary question put up by INC member Kumar Waii on whether the Government is taking up policies on defunct schools in the state.

The Education Ministerin formed that requisition of teachers have been given to the APPSC to rationalize the shortage of teachers in the Education Department while answering the question put up by MLA Pani Taram.

While agreeing with the opposition Member Thangwang Wangham, about air pollution, hazards caused to the environment and public health by the Iron Smelter factory at Lekhi Village the Minister Environment and Forest Department, Wangki Lowang said thatit is concerning for the people but unavoidable since industrialization is also necessary for the development. Saying that "development and pollution is complementary to each other" permissible limit of pollution needs to be set, the Minister added.

Regarding the quartz consumption as a raw material in the factory in question, the Minister informed the house that there is no mining of quartz so far in the state, therefore the resources are not supplied by the government, so the question of royalty or revenue does not arise as far the raw material for the factory is concerned. Earlier, Dr. Mohesh Chai, Advisor Health & Family welfare and Commerce & Industries informed the house on the starred question put forward by him to the Minister of Land Management on whether any land was allotted for the establishment of JNV school at Tezu, informed the house that in the 1980s a plot of land was allotted for the establishment of JNV school which had been encroached and that a "chaipatti bagan" is in place in the allotted land.

Marathon discussion on the Budget Estimate

Arunachal is one of best performing Sate in country in terms of capital investment: CM

ITANAGAR, July 25:

The ArunachalPradesh Appropriation (No.2) Bill was passed in the house on Thursday, July 25 after a marathon of discussion on the Budget Estimate which was presented by Deputy Chief Minister Chowna Mein on July 24 in the State Legislative Assembly.

Pema Khandu, Chief Minister of the state gladly informed that the state is one of the best performer states in the country in terms of capital investment. He said that the government is hopeful of achieving the target of "Viksit Arunachal" by the next 10 to 15 years. The government has adopted 'Bottom Up' approach in the planning process, thereby empowering the districts. Since youths are the future therefore the government has declared the year as the "Year of Youth". He urged the youths to take advantage of Deen Dayal Swalamban Yojana and UNNATI - 2024.

To meet up the shortage of teachers in the schools, the government had come up with a scheme namely, Mukhya Mantri Shiksha Kosh, as a temporary measure since the APPSC was not in place. Through it nearly 773 teachers have already been posted at schools and 200 more are to be added. While 600 posts are already with the APPSC.

He informed that the government would entirely sponsor any APST student who bags a seat in the IIT (Indian Institute of Technology). He further informed that even at international level, if any APST student gets admission in any university that is within the 150 QS World University ranking, the state would sponsor 75% of the total expenses and even the student was unable to bear the remaining 25%, the government would gladly sponsor the remaining 25% as well.

The state aims at rolling out the National Education policy 2020 in the state soon, saying that the focus will mainly be on the primary schools. 900 Primary schools have already been started.

The CM assured renovation of dilapidated structure in phase wise manner as the government would focus on infrastructure development in the coming 5 years.

This year, under PMG-SY 645.52 kms road has been sanctioned within an investment cost 665crores. Also under the Vibrant Village programme 105kms road have been sanctioned covering around 1022kms of road, the tendering process of which is under process. Within the interstate highway project, 2878kms of new highway will be constructed and the tendering process has been initiated for the same, the CM added.

Since, the government exchequer is spends a lotin paying a huge amount of government fund to the service holders (regular, contractual, contingency workers) pensioners and for developmental activities, income generation is the need of the hour for the government.

In conclusion, he announced that to ensure quality work for larger infrastructure on ground, the government plans on strengthening monitoring process by engaging a third party which would be an independent agency.

Deputy Chief Minister, Chowna Mein informed that Healthy human resource; Robust Infrastructure and Vibrant economy were the 3 pillars of the Budget estimate 2024-25. The whole budget has been framed around these 3 pillars. The government aims nurturing the youths for bright future of the state and sat strengthening governance, ease of living and business, administrative reforms, connectivity, social security, etc. Replying to the questions put up by the members earlier. Mein informed that

GoAP to formulate policy to promote agri, horticulture- The state government will formulate its maiden agriculture and horticulture policy to motivate the youths towards farming, the Arunachal Pradesh Legislative Assembly was informed on Thursday, July 25.

Agriculture, Horticulture, Fisheries & Diary Development Minister Gabriel Denwang Wangsu said that various experts and stakeholders would be involved to make the policy attractive to the youths of the state.

The minister was responding to a question raised by lone Congress member Kumar Waii during the question hour.

The state budget for 2024-'25, which was presented in the House by Deputy Chief Minister Chowna Mein on Wednesday, mentioned framing a new 'farm to fork' agricultural and horticultural policy, focusing on natural farming, higher farm gate prices, enhanced market linkages and export of crops, fruits, vegetables and flowers.

The government has kept a provision of Rs 621 crores in the budget for the agriculture and allied sectors, Wangsu said.

"Through the policy, we will try to catch up with more young farmers to make them members of the hardcore farming community via a scientific approach," the minister said.

Responding to a supplementary question from the Congress legislator, the minister said that there is no wasteland as such declared in the state and reclamation of acidic soil is taken up on cultivated fields only.

He assured the members that the government would work in the interest of farming community of the state

While replying to the question of whether any steps

is being taken up by the government to fix the appointment and retirement age of contingency workers by Nampong MLA Laisam Simai, RWD Minister PD Sona said it was high time that the government took a decision regarding the retirement age of the contingency workers. He assured that the ministry would formulate system on equitable distribution of contingency workers. Speaker Tesam Pongte also suggested the government to take up measures on the above issue and on decentralization of recruitment of contingency workers at EAC and CO levels.

The Arunachal Pradesh Police has been facing an acute shortage of police personnel, informed Home Minister Mama Natung in the House during the Question Hour. The shortage of personnel is due to creation of new districts and the inability of the recruiting agencies to complete the process on time, the Minister added.

Responding to a question from BJP MLA Wanglin Lowangdong during question hour, Natung said that his department could not even fill the sanctioned posts in many districts.

In 2011, the union home ministry announced a special package for the Tirap, Changlang and Longding (TCL) region, sanctioning 1,949 posts of civil police.

Of those posts, 140 are still pending, the home minister said.

Natung said that in April 2018, the home department had advertised, inviting applications for 82 vacant posts for the three eastern districts. However, the advertisement was cancelled due to procedural issues.

"The home department later submitted a requisition against those posts to the Arunachal Pradesh Staff Selection Board for recruitment, which is under process. Once the recruitment is completed, the vacant posts will be filled up," he added.

Responding to a supplementary from another BJP member Jikke Tako, Natung said that the state Cabinet has decided to post adequate police personnel in various districts after the recruitment process is over.

The Speaker adjourned the house sine die.

Earlier, on 28 July, Tasing held a district-level coordination meeting at the DC's conference hallhere, where all the five departments under the minister's purview presented their reports.

Tasing urged the HoDs and the panchayat leaders to "work harder and be more proactive in implementing developmental projects."

He emphasised the importance of adhering to the state government's 100-day action plan policy, and assured to make efforts to modernise the transport system, including infrastructure, to ensure smooth operation of transport services in the district.

Sawin requested the minister to provide a Volvo bus for the district.

Earlier, PD Nangram Pingkap provided an overview of the panchayati raj institution and rural development in the district, highlighting various challenges, such as acute shortage of staff and the lack of vehicles in the department.

The station superintendent presented a brief history of the state transport service in the district, and emphasised the need for its upgradation. He highlighted that, "due to shortage of vehicles, three routes – Khonsa to Lazu, Khonsa to Dadam, and Deomali to Soha – have been discontinued, causing hardship to the public."

The district registrar of cooperative societies provided an overview of the cooperative societies in the district, and requested appointment of a regular DRCS, besides seeking a JICS or SICS to be posted to the district.

On Tuesday, Tasing visited Changlang district, where he laid the foundation stone of the District Panchayat Resource Centre, funded under the Rashtriya Gram Swaraj Abhiyan.

DA for strict implementation of "Prohibition of Employment as Manual Scavengers & their Rehabilitation Act 2013"

PASIGHAT, July 31:

DC East Siang Tayi Taggu has asked all stakeholders for strict implementation of the "Prohibition of Employment as Manual Scavengers and their Rehabilitation Act 2013 in the district and asked for conducting time bound survey and submission of report at both Sub-divisional and district level and for extending support for skill development and assistances under various livelihood schemes etc for a dignified life.

The DC also directed PMC to conduct a survey on insanitary toilets within the municipality areas so that these to be replaced with sanitary toilets.

The DC who is also the Chairman District Vigilance Committee said this while chairing the District Vigilance Committee (DVC) of East Siang District on the implementation of the "The Prohibition of Employment as Manual Scavenger and Their Rehabilitation Act 2013" in the district.

MLA Tapi Darang, in his address asked the District Administration and PMC authority to implement the Act, in letter and spirit, so that any beneficiaries or individuals found engaged as manual Scavenger are given a proper rehabilitation and other facilities as per the Act.

The local MLA also pointed out to the PMC authority to conduct a proper survey along the stretches of Pane Korong stream and other habitations as insanitary toilets are contaminating and polluting the streams through direct disposal of wastes /septic pipe wastes directly into the stream which is posing health hazard and risk of spread of diseases to the citizens/ dwellers. The MLA also called for conducting awareness drive among the citizens.

The SP East Siang, Dr. Sachin Kumar Singhal also assured support for strict enforcement as per provisions of the Act.

Chief Councillor, PMC, Okiam Moyong Borang, informed that a preliminary survey on insanitary latrines/septic tanks have already been initiated and Fund proposal for conversion of insanitary latrines and other equipments shall be placed before the state Government, she added.

ZPC, Olen Rome, also suggested offered suggestions for effective implementation and awareness campaign.

The House resolved for formation of sub-division vigilance committee (Ruksin and Mebo) and Survey Committee for East Siang.

EE PMC, Er. Tadar Tarang, in his PPT presentation, highlighted on the salient features of the "Prohibition of Employment as Manual Scavengers & their Rehabilitation Act 2013" and the objectives of the Act to eliminate manual scavenging and rehabilitate to a life of dignity, use of modern technology for cleaning of sewers, septic tanks etc, to eliminate insanitary toilets, being punishable offences, he highlighted penalties for construction of insanitary latrine or engaging manual scavengers, the prohibition of persons for employment for hazardous cleaning of sewers and septic tanks, role of Urban and Local bodies for construction of sanitary community toilets to eliminate open defecation etc.
