PUBLIC NOTICE

WHEREAS,

Hon'ble Supreme Court Vide its adjudication in the civil appeal case No. 2868-2870 of 2021 has banned the sale and use of traditional firecrackers during festival time.

AND WHEREAS,

Hon'ble Supreme Court has adjudicated, that green firecrackers have 30% lower emission with 120 decibel noise level can be allowed.

AND WHEREAS,

Celebration of festivals cannot be at the cost of others' health that may infringe the right to health as guaranteed under section 21 of the constitution of India, more particularly to the health of senior citizens, children, sick people as well as animals.

WHEREAS,

Failure to comply shall invite a necessary penalty with imprisonment of one year and six month as per, The Air (Presentation and Control of Pollution) Act, 1981, The Water Act, 1974, The noise Pollution (Regulation and Control) Rules, 2000 framed under the Environment (Protection) Act, 1986, The Solid Waste Management Rules, 2016 as well as under appropriate provision of the Explosive Rule 2008 framed under the Explosive Act, 1884.

AND NOW, THEREFORE,

All the licensed traders of various wards under the Itanagar Municipal Corporation are hereby directed, to sell only green firecrackers of PESO (Petroleum and explosive safety organisation) certified trademark with having emission and sound decibel level as mentioned herein above only after obtaining a proper permit from undersigned office. Further, it is also hereby instructed to all citizens within various wards under Itanagar Municipal Corporation to use and burst only fire crackers between the timing of 8:00 PM to 10:00PM only on the main day of celebration i.e.; **31st October 2024** as per the Central Pollution Control Board Order.
