**NOTICE INVITING TENDER/INVITATION OF BID**


Item rate tender is hereby invited on behalf of Governor of Arunachal Pradesh from all Registered & eligible Contractor and Vendors/Firms having valid Trading license with GST Registration, for **Supply and Procurement of materials under MGNREGA 2024-25** in respect of **Tawang** District for an amount as mentioned package wise, in CPWD Form-8 in two bid system from all registered contractors/ Suppliers/Vendors domiciled within the territorial jurisdiction of **Tawang** District as per Arunachal Pradesh Based Entrepreneurs and Professionals (Development and promotional) Act 2015, published vide Notification No. SPWD/W-68/2012 Dtd **13<sup>th</sup> August, 2015** and published in Arunachal Pradesh Extra Gazette No. 247 Vol.XXVII dtd. 2<sup>nd</sup> November 2020 for the work as stated below:-

- I. - II. The Earnest money shall be accepted in form of Demand Draft of a Scheduled National Bank guaranteed by Reserve Bank of India issued in favour of the Project Director, RD Tawang District.

**TERM AND CONDITIONS**

1. The contractors/Vendors/Firms should furnish the following initial requirements along with application form and requisites cost of tender documents for issue of tender papers:
  - i. The applicant contractor/Vendor/Firm must produce original Contractor registration certificate/ Valid Trading License, GST registration certificate with valid GST return file certificate, TIN/TAN in the name of the registered firm along with upto date income tax clearance certificate.

- ii. The applicant Contractor /Vendor/Firm shall submit No-dues Certificate (NDC)/No objection Certificate (NOC) from the concerned Nationalized Bank operating his account duly issued by the Branch Manager in order to participate in the tender.
  - iii. The applicant Contractor must produce Non-Litigation Certificate. The contractor /Vendor/Firm having litigant history shall not be issued tender documents.
  - iv. Produce Work Experience Certificate having satisfactorily completed similar nature of works for last three years.
2. The tender without Earnest Money shall be summarily rejected.
  3. Joint ventures are not acceptable.
  4. The tendered should have a minimum annual financial turn on supply work of at least 70% of the estimated cost during the preceding last 3 consecutive financial years.
  5. Acceptance of tender at justified rates with allowable variation as per CPWD works manual 2014, 20.4.3.2 shall be strictly followed.
  6. The Contractor/Vendor/Firm should have solvency certificate from any nationalized bank not less than 50% of tendered amount.
  7. The vendor/firm should be domiciled within the territorial jurisdiction of **Tawang District**, Arunachal Pradesh complying District base Entrepreneur Act 2020.
  8. Tender Paper duly completed in all respect should be submitted in one large envelope marked as "Supply and Procurement of materials under MGNREGA 2024-25" for Package-I to VI containing 2(two) separate sealed envelopes for Technical Bids and Financial Bids.
  9. The bidder will have to adhere to all the terms and condition laid down in tender documents.
  10. The Supply works should be carried out as per the approval NIT Quantity, Quality and Specification of materials.
  11. The undersigned reserves the right to accept/reject any or all tenders received without assigning any reason thereof.
  12. In case of any dispute, the legal jurisdiction of the case will be within **Tawang District**, Arunachal Pradesh.
  13. All other term and conditions shall be reflected in the technical bid documents which will be issued to the interested bidders.
