PUBLIC NOTICE

In exercising the provisions under Section 355 & 356 of Arunachal Pradesh Municipal Act 2007 and Section 589 (XIII), Section 69 (e) & (f) 111, 112, 113, 245 & 256 (e) of Arunachal Pradesh Municipal Act 2019 read with the water (prevention & control of pollution Act, 1974, Environment (Protection) Act, 1986, Solid Waste Management Act & Rules, 2016 as well as Green Tribunal Act, and also in pursuance to the guidelines issued by the Central Pollution Control Board, the following with norms and modalities are hereby laid out for strict compliance in public interest in respect of organizing puja/festival within the IMC Jurisdiction.

1. All the organizers of Chhath Puja 2024, organized under IMC Jurisdiction, are hereby directed to obtain permission from the office of the Commissioner IMC for the erection of a temporary structure/booth/pandal or any other structure within IMC Jurisdiction for the celebration of Chhath Puja under the aforementioned sections to avoid punitive action upon inspection made by the Permanent Festival Monitoring Committee constituted for the purpose.
2. Chhath Puja is celebrated along the river banks, so immersion of non-biodegradable puja material is strictly prohibited.
3. The celebrators shall voluntary conduct a cleanliness drive along the river bank after the celebration, shift the garbage, and dump it at the landfill/dumping site at Chimpu MSW Plant, Itanagar.

Therefore, the citizen/puja committee is hereby directed for strict compliance with the direction to avoid penal attraction under Section 15 of the Environment Protection Act, 1986, Sections 15 and 17 of the NGT Act, 2010 and other relevant provisions.

The Superintendent of Police, Itanagar & Naharlagun, is hereby requested to deploy adequate security to maintain law and order during the period.
