All are requested to use the online facilities to file the application through "Voter Helpline" Mobile App or <a href="https://voterportal.eci.gov.in">https://voters.eci.gov.in</a>. Wherever online facilities are not available they may use offline forms for inclusion of name in Form-6, deletion in Form-7, Correction and Transposition in Form-8, which are available in all Electoral Registration Officer's/Asstt. Electoral Registration Officer's Office and designated Locations. The forms dully filled up may hand over to the Booth Level Officers of the respective Polling Station of your location.

ALL THOSE ELECTORS WHOSE NAME APPEARS AT MORE THAN ONE LOCATIONS IN THE ELECTORAL ROLLS, THEY ARE ADVISED TO FILE FORM-7 FOR DELETION WITH THE CONCERNED ELECTORAL REGISTRATION OFFICER OR BOOTH LEVEL OFFICER (BLO), FAILING WHICH NECESSARY CRIMINAL ACTION WILL BE TAKEN AGAINST SUCH ELECTORS.
